

Press Release About Savings Financing Companies

As it is known, with the Board Resolution dated 01.07.2021 and numbered 9647 which was published in the First Duplicate Copy of Official Gazette dated 02.07.2021 and numbered 31529, as a result of joint evaluation of the findings in the Reports prepared as a result of the examinations made by the audit personnel of the Agency and the provisions of the relevant legislation, it has been decided to liquidate 21 companies that have applied to our Agency to comply with the provisions of the Financial Leasing, Factoring, Financing and Savings Financing Companies Law No. 6361 (Law) and whose adaptation plan was not assessed as sufficient, within the scope of the fourth paragraph of the Provisional Article 7 of the Law.

It has also been decided to continue the adjustment process of 6 companies and to direct 8 companies to voluntary liquidation. These companies are listed in the attached list.

The aforementioned decisions were taken in the light of the findings reached by our Agency within the scope of the elaborate adjustment examination and in the ongoing process, all necessary actions to protect the rights and interests of the savers will be promptly taken by the liquidation commission and our Agency, depending on their relevance.

In this respect, our Agency's evaluations are continuing in terms of companies whose adaptation examination is ongoing and there is no restriction on the activities of the companies in question.
